



SOLYX® SimGlas® WINDOW FILMS WARRANTY DOCUMENT

SOLYX® Glass Finishes (“Products”) are decorative films for use only in vertical interior glass applications in commercial buildings (“Interior Applications”). Products may also be used in vertical exterior glass applications in commercial buildings, however Decorative Films LLC, makes specific Product warranty for those exterior applications.

Limited Warranty:

1. For SOLYX® Products used in Interior Applications in the continental United States, Decorative Films LLC makes the following warranty (the "SOLYX Warranty") for the applicable time period stated below ("Warranty Period"), which will begin on the earlier of: (a) Product installation date; or (b) six months after Decorative Films LLC Product shipment date:

1.1 The Product will have the National Fire Protection Association Class AI level (as defined in NFPA 101 “Life Safety Code” Test Method ASTM E84) for five years.

1.2 The Product will have no significant discoloration, peeling, swelling or other similar appearance defect that is caused by that Product's adhesion quality for the applicable time period below:

2. For a buyer’s convenience, Decorative Films LLC may provide a Product Technical Data Sheet/Product Bulletin, other engineering or technical information, recommendations, installation instructions, and other Product-related information or materials (all collectively referred to as “Product Information”), but Decorative Films LLC does not warrant any Product Information.

3. The Decorative Films LLC Warranty is contingent on the Product being stored, applied, installed, maintained, and used only as Decorative Films LLC recommends in all Product Information and in this Warranty Document. Also, Decorative Films LLC has no obligation under the Decorative Films LLC Warranty as to Product that has been: (a) printed on, modified, altered, or processed in any manner; (b) damaged through contact with a person or thing, misuse, accident, vandalism, neglect, or other action by anyone other than Decorative Films LLC; or (c) affected by environmental conditions, such as power fluctuations, improper power supply, or activity by animals or insects or (d) improper storage.



4. EXCEPT TO THE EXTENT PROHIBITED BY APPLICABLE LAW, THE DECORATIVE FILMS LLC WARRANTY IS MADE IN LIEU OF ALL OTHER WARRANTIES, RIGHTS OR CONDITIONS, EXPRESS OR IMPLIED, STATUTORY OR OTHERWISE, INCLUDING, BUT NOT LIMITED TO, ANY IMPLIED WARRANTY OF MERCHANTABILITY, SATISFACTORY QUALITY, FITNESS FOR A PARTICULAR PURPOSE AND THOSE ARISING FROM A COURSE OF DEALING, CUSTOM OR USAGE OF TRADE. THE BUYER IS RESPONSIBLE FOR DETERMINING IF A PRODUCT IS SUITABLE FOR ITS PARTICULAR PURPOSE AND ITS APPLICATION METHODS.

Limited Remedy:

Decorative Films LLC must receive any Decorative Films LLC Warranty claim in writing by the earlier of: (a) applicable Warranty Period's expiration date; or (b) ten business days after Product buyer's discovery of that claim. If the Product is proven not to have met the Decorative Films LLC Warranty during the applicable Warranty Period, then THE BUYER'S EXCLUSIVE REMEDY AND DECORATIVE FILMS LLC'S SOLE OBLIGATION, WILL BE AT DECORATIVE FILMS LLC'S OPTION, TO REPAIR OR REPLACE THAT PRODUCT QUANTITY OR REFUND THE APPLICABLE PURCHASE PRICE.

Limitation of Liability:

DECORATIVE FILMS LLC'S WILL NOT UNDER ANY CIRCUMSTANCES BE LIABLE TO A BUYER FOR DIRECT (other than the Limited Remedy above), SPECIAL, INCIDENTAL, INDIRECT OR CONSEQUENTIAL DAMAGES (INCLUDING, WITHOUT LIMITATION, LOSS OF PROFITS) IN ANY WAY RELATED TO A PRODUCT, THIS WARRANTY DOCUMENT, OR PRODUCT INFORMATION, REGARDLESS OF THE LEGAL OR EQUITABLE THEORY ON WHICH SUCH DAMAGES ARE SOUGHT.
